Aim of the meeting:

The objective of the Study Visit is to receive detailed knowledge on identification of new psychoactive substances in biological samples of intoxicated patients and providing the most effective medical care.

This request is connected with the Application form for TAIEX expert mission on assessment of the Early Warning System on New Psychoactive Substances in the Republic of Croatia (NEWS), which should serve as a base for revision of the structure and operational protocols of the NEWS with the purpose of increasing its effectiveness.

As the **Pavia Poison Control Centre** in Italy is responsible for coordinating clinicaltoxicological aspects of the Italian Early Warning System on New Psychoactive substances and has a reputation of the centre of excellence in this area in the EU, it would be beneficial for a group of Croatian medical doctors and toxicologists to get acquainted with their work in order to develop appropriate model in Croatia.

Effective responding to the NPS phenomenon presumes continued monitoring all of its aspects. Therefore it is essential to develop monitoring of adverse health consequences of NPS use in Croatia, which would include incising scientific and professional capacities of clinical toxicology laboratories, emergency wards and other relevant subjects in the health sector, related to identification of NPS in biological samples and effective treatment of intoxicated persons. Such an undertaking would require also appropriate laboratory instruments and referent materials for identification of NPS in health sector, but what is even more important building the knowledge in toxicological analysis and clinical practice.
